US Polo growth hinges on premiumization

American casual wear brand also plans to invest in adjacent categories

American casual wear brand U.S Polo Assn. India is on track to touch ₹3,000 crore in business over the coming years as the brand targets opening more premium stores and investing in adjacent categories such as kids' wear and footwear.

"When I think about India in particular, it's been our fastest growing market, and I believe it has the most long-term potential than any market in the world. India is the third-largest market for the brand apart from America (US) and Turkey," said J. Michael Prince, president and chief executive officer (CEO) of United States Polo Association (USPA Global).

U.S Polo Assn. is the official brand of the United States Polo Association, the governing body for polo in the US since 1890.

The brand entered India in 2007 via a licensing agreement with Arvind Ltd. U.S Polo sells casual clothing and footwear for men, women and kids, such as its signature polo T-shirts with apparel priced between ₹799 and ₹4,999.

The retailer operates over 430 stores across India. It is the largest brand in terms of sales and number of stores within Arvind Fashion Ltd's portfolio. Globally, the brand retails via 1,100 stores.

"During covid, U.S Polo Association numbers that came close to ₹1,000 crore were impacted, but now we are crossing ₹2,000 crore; in the last three-and-a-half years, we have doubled the business of the brand in India. We are now imagining when we will hit ₹3,000 crore. Our guidance has been to grow at 12% to 15% per annum, and we are seeing extremely strong momen-

turn on the brand," said Shailesh Chaturvedi, managing director and CEO of Arvind Fashions.

BSE-listed Arvind Fashions sells its five brands across 9,000 single and multi-brand stores in India. Its portfolio includes Tommy Hilfiger, Calvin Klein, Arrow, U.S

U.S Polo Association entered India in 2007 through a licensing agreement with Arvind Ltd

THE US brand sells casual clothing and footwear for men, women and kids such as polo T-shirts

Polo, and Flying Machine. In fiscal 2024, the company reported sales of ₹4,259 crore.

This management commentary comes amid continued weak demand for clothing and footwear. Due to high inflation, middle-class consumers are prioritizing value, while affluent shoppers are shifting

spending to travel and luxury items.

However, Chaturvedi said the broader trend of consumers switching to more casual clothing and buying more premium apparel and footwear bodes well for the retailer. Arvind Fashions has maintained its forecast of opening 150 stores annually. "A lot of those 150 stores would come from U.S Polo. We are looking at a very large development of adjacent categories like women, kids, footwear, etc. U.S Polo will continue to grow its store footprint across India," he said.

In the last 12 months, the company has opened 15 large-format stores for the brand. Chaturvedi said the brand will continue investing in marketing and launch more premium collections to appeal to younger consumers.

Coursera relies on India to boost its enterprise business

India has emerged as the biggest opportunity for Coursera Inc.'s enterprise business, making it one of the two fastest-growing markets for the global upskilling giant, alongside West Asia, for the vertical, according to a top company executive.

The company's enterprise segment, which caters to businesses, universities, and governments, is experiencing significant traction in India, Karine Allouche, vice-president and general manager of enterprise business at Coursera, told *Mint*.

"No other country has the same demographic advantage. Additionally, not all governments have advanced the digitalization of their institutions to the same extent. In most countries, you don't see 40% of credits being delivered online," Allouche said.

Coursera, led by new chief executive Greg Hart, operates two primary segments: Business-to-consumer (B2C) and business-to-business (B2B). The B2C segment is further divided into online courses and online degrees, while the enterprise business includes three subcategories: Coursera for Campus, Coursera for Business and Coursera for Government.

Within the enterprise business, Coursera for Campus has been a star performer. Nearly 30% of Coursera's global campus customers are based in

India, underscoring the success of its Coursera for Campus in the country. Overall, in 2024, Coursera's B2B segment contributed approximately 34% of its total revenue, up from 29% in 2021. Meanwhile, the B2C segment, though still the largest contributor, saw its share decline from 59% in 2021 to 57% in 2024.

Allouche pointed out that India is an exception to this global revenue split for Coursera, with the enterprise segment making up a larger chunk than the consumer business. The company, however, did not disclose the revenue

split for its Indian operations. India is also Coursera's second-largest consumer market, with 28 million registered users as of December 2024, trailing only the US. In fact, in 2024, India recorded the highest enrollments on the platform, surpassing even the US.
