Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015

In continuation to the announcement made by the Company on November 14, 2025, wherein the Company had intimated regarding the pending litigation and in compliance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, please find below update in the litigation:

1.	The details of any change in the status and / or any development in relation to such proceedings	<p>The Company is engaged in the manufacture of various electrical equipment, including relays. Between the year, 2002 and 2014, the Company availed an exemption from the payment of Basic Customs Duty on the import of various “parts” that were used in the manufacture of “relays”.</p> <p>A writ petition was filed by the Company before the Hon'ble Madras High Court against the Order-in-Original dated 25.03.2015, passed by the Assistant Commissioner of Excise on jurisdictional grounds. The Hon'ble Madras High Court dismissed the writ petition and directed the Company to the appellate authority.</p> <p>The Company filed a Special Leave Petition on 13.11.2025 before the Hon'ble Supreme Court seeking Special Leave against the judgment passed by the Hon'ble High Court of Madras and seeking ad-interim ex-parte stay of the Order-in-Original dated 25.03.2015.</p> <p>The Hon'ble Supreme Court of India <i>vide</i> its order dated April 8, 2026, received on April 10, 2026, dismissed Special Leave Petition and permitted the Company to avail the remedy of filing appeal before the Commissioner (Appeals).</p> <p>The Company will be filing appeal, on merits, before the Commissioner (Appeals) against the Order-in-Original dated 25.03.2015 passed by the Assistant Commissioner of Excise.</p>
