GE T&D India Limited announces First Quarter, Financial Year 2023-24 results

New Delhi, India — August 08, 2023 — GE T&D India Limited, reported on Aug 08, 2023 its unaudited financial results for the first quarter ended 30 June 2023.

For the first quarter (1 April 2023 - 30 June 2023)

- Sales revenue was INR 7.2 billion up 21.0%, compared to INR 5.9 billion in Quarter Ended (QE) June

- Operating Profit at INR 499.4 million (7.0%), against operating profit of INR 180.5 million (3.0%) in QE June 22
- Profit after tax at INR 282.4 million (3.9%), against net profit of INR 63.6 million (1.1%) in QE June 22
- Order bookings were INR 10.1 billion up 67.9% compared to INR 6.0 billion in QE June 22
