2 Financial results for the quarter and six months ended 30 September 2016 are in compliance with the Indian Accounting Standards (Ind-AS) prescribed under Section 133 of the Companies Act, 2013. Consequently, previous Indian Generally Accepted Accounting Principles (IGAAP) result for the quarter and six months ended 30 September 2015 have been restated to make them comparable. Reconciliation of net profit /loss as reported under previous IGAAP and as restated now under Ind AS is as under:

- 3 Consequent to re-evaluation of tax risks (including related recoverable balances) Rs. 87,30 lacs has been accounted during the quarter.
- 4 Consequent to revision in specific ongoing projects the estimate of the costs to complete of few specific ongoing projects, an additional cost of Rs. 62,20 lacs, Rs. 126,85 lacs, Rs. 145,10 lacs and Rs. 140,51 lacs has been recorded during quarters ended 30 September 2016, June 2016, September 2015 and six months ended 30 September 2016 and 2015, respectively.
- 5 Exceptional item represents cost relating to restructuring carried out during the quarter and six months ended 30 September 2016.
- 6 The Company's business activity falls within a single business segment i.e. Power Generation.
- 7 The above unaudited results were reviewed by the Audit Committee and approved by the Board of Directors at its meeting held on 2 December 2016. The unaudited results for the quarter and six months ended 30 September 2016 have been subjected to limited review by the Statutory Auditor of the Company. The figures relating to the quarter and six months ended 30 September 2015 as per previous IGAAP were reviewed by the erstwhile Statutory Auditor. Those results, as adjusted for the differences in the accounting principles adopted by the Company on transition to the IndAS, have been reviewed by the current Statutory Auditors.
- 8 The review report of the Statutory Auditors is being filed with BSE Limited and National Stock Exchange of India Limited. We have reviewed the accompanying statement of standalone unaudited financial results of GE Power India Limited (formerly known as "Alstom India Limited") for the quarter and six months ended 30 September 2016 ("the Statement"), being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The financial results for the quarter and six months ended 30 September 2015 included in the Statement, are based on the previously issued results of the Company prepared in accordance with the Accounting Standards as per Section 133 of the Companies Act, 2013 and other recognised accounting practices and policies, reviewed by the predecessor auditor, whose report dated 9 November 2015 expressed unmodified opinion on those standalone unaudited financial results, as adjusted for the differences in the accounting principles adopted by the Company on transition to the Indian Accounting Standards ('Ind AS'), which have been reviewed by us.

This Statement is the responsibility of the Company's management and has been approved by the Board of Directors on 02 December 2016. Our responsibility is to issue a report on the Statement based on our review.

We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410 'Review of Interim Financial Information Performed by the Independent Auditor of the Entity', issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of Company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and, accordingly, we do not express an audit opinion.
